Isaac Wesley Brown died July 8, 1942. Iona Boone Brown died July 15, 1963.



M.C. AND SARAH CAMPBELL

Melville Clark Campbell, son of James and Priscilla (Mick) Campbell, was born September 6, 1849, in Crete, Will County, Illinois. He married Sarah Ellen Smith, daughter of James Bolivar and Mary (Bryson) Smith, on October 1, 1876. She was born on September 8, 1859, in Bonaparte, Van Buren County, Iowa. Mr. Campbell died on October 12, 1932, in Wichita and Mrs. Campbell died on December 7, 1962, in Ashland. Both are buried in Old Mission Mausoleum Cemetery, Wichita.

He often said that when he first saw her, she was the "prettiest pink-cheeked girl" he had ever seen. He had come to Barton County in 1874, and she came with her parents on May 1, 1876. They were married in October of that year. Two children were born: Jetta Grover Campbell (Stanley) on August 31, 1879, and Melville Helen Campbell (Harper) on June 17, 1889.

Mr. Campbell was engaged in the cattle business for all of his

adult life. They lived in Great Bend until moving to Wichita in 1879. In 1882, he participated in the Cherokee Strip land movement and supplied horses to the XIT Ranch. In 1888, he formed a partnership with Mr. Eldridge and operated the Eldridge-Campbell Livestock Commission Co. In 1890, he started blocking up his ranch in Cimarron Township, Clark County, Kansas, and the ranch grew to 20,000 acres. The ranch house originally consisted of two school houses built in 1890, put together, then a kitchen added and more rooms added later. In 1940, the house was covered with native stone, collected from the hills north of Ashland, uncut and in their natural state. The ranch is along six miles of the Cimarron and has four creeks running through the land.

Mr. Campbell bore great love for good horses, fine Hereford cattle, and the Kansas prairies. He was a member of the Board of Directors of the Texas Cattle Growers Association, appointed to the Livestock Sanitary Board of Kansas and chaired its board for six years, helped to organize the National Bank of Commerce of Wichita in 1896, and served on the Board of Directors until it was consolidated with the Kansas National Bank, forming the First National Bank of Wichita. He served on its Board of Directors until his death. He helped to organize and was a charter member of the Kansas Livestock Association, serving as its president in 1926. He was affectionately known as the "Dean of the Kansas Cattlemen."

Mrs. Campbell took an active part in the entertainment of the wives of cattlemen in her home at 1313 N. Emporia, Wichita, Kansas. Her church held first place in her life after her home. In June of 1895, she joined the First Methodist Episcopal Church in Wichita. Through all the years of her residency in Wichita, she was active in the work of the women in her church.

During the years of the pioneers, education often became learning by doing and the experience meant that every man and woman had to study out his own problems for himself, and cooperated with his neighbors for the good of the whole community. Mrs. Campbell was active in all kinds of civic activities and as the city grew, the activities grew in nature and size. She served on the Board of the first hospital in Wichita, which was located on the corner where St. Francis Hospital now stands. She served as treasurer on the board of the Wichita Hospital, in west Wichita, for many years. She was a charter member of the YWCA in Wichita, and of the Wichita Baby Camp, which later grew into the Wichita Child Guidance Center. As a money making endeavor, the Wichita Hospital Board sold box seats for the Wheat Show and the Horse Show at the Forum and she chaired this committee for many years.

Mrs. Campbell was a lover of good horses, had her own riding horse in early years, later driving a fine looking team of black horses. But when the automobile came into vogue, she deserted her first love for a Buick Sedan. She also learned to use the type-writer after middle life and used it consistently in writing letters and making genealogical charts.

One of Mrs. Campbell's precious mementoes left to her family is a book of stories of her early life, written on the typewriter and placed in a loose leaf notebook, one complete story on each page.

It is her legacy: by her own telling, her life will live and live and live. Although she lived to the age of 103, she never grew old in mind for she clung to the activity that went on around her every day.

They were members of the Christian Church. Isaac, having served in the Indiana Infantry during the Civil War, was an organizer of Ashland's Major Elliott GAR Post. In addition to Nora and Hattie, their other children were Arthur (who died at 5),

Harry Brannon Christman was born in a sod dug-out 2½ miles east of Ashland, on July 20, 1887, on land homesteaded by his parents, John and Alice Turner Christman, in 1883. Harry's father, John Christman, had walked most of the way from Indiana in 1882, to choose the land, returning to Clark County around 1885 with Harry's mother and brother, Carl Clifford Christman, in a covered wagon to file the claim. An only sister to Harry and Carl died stillborn. Times were hard and Harry's mother, Alice, died at age 39, when Harry was about eight years old. After that, he grew up in a world of men, cattle, horses and hard work.

By the age of twelve, Harry began his trail rides and became the horse wrangler for the outfit. He worked on ranches and because of his love for animals, became one of the few and best unlicensed veterinarians in Western Kansas. He developed

the homestead and added holdings to it, enjoying his farming, particularly his Hereford cattle.

He was a great worker in the Masonic Lodge in Ashland and received the honor of being Knight Commander of Court of Honor, conferred upon him by the Wichita Consistory, Wichita, Kansas.

On November 10, 1910, Harry was married to Abbie Gertrude Johnston in Columbus, Kansas, where she was born on March 6, 1891. Gertrude, "Gertie," had a twin brother, Fred. They were fourth and fifth in a family of seven children. Their parents were James Oscar and Mary Ellen (Medley) Johnston, who had moved from Columbus, from farming and strip mining, to Texas, then to Clark County, just one-fourth mile east of the Christman farm. Gertie made a comfortable home from very little resources. They kept Harry's brother Carl for several years and his father John Christman until his death in 1918. Gertie was endeared by her family and community for her devotion to the home, neighbors, and the First Baptist Church. 



Donley and Willie went to Alex Floyds to borrow bed blankets for the night. Next morning we all started for our home, driving over snow drifts, over snow-covered fences, since the roads were blocked.

GEORGE WASHINGTON CURTIS FAMILY

The George Curtis family came to Clark County from their home in Bushnell, Illinois, after Mr. Curtis was discharged from the Union Army of the Civil War. He had married Mary Dodge and five children were born while still residing in Bushnell. Their names were: Milton, Belle, Elizabeth, Fidelia and William George.

The family first moved to Wellington, Kansas, where the parents operated a hotel and boarding house. Mr. Curtis decided to come to Clark County to stake a claim, and located about three and a half miles north of Ashland, which later became the Hart farm. His oldest daughter, Belle, and family lived on the claim. This was the year of the last Indian scare, which was later proved to be a "scare campaign" promoted by the cattlemen to try to 218

keep the settlers out of the grazing areas.

In the spring of 1884, the family moved to Clark County. William, then only twelve years old, drove a team of oxen from Wellington to Ashland, and the family followed in a covered wagon. Mr. Curtis became a plasterer and helped for many years in the construction of buildings and homes in the new little pioneer town of Ashland.

While still living on the farm, Mrs. Curtis died, and Mr. Curtis moved to Ashland. In 1893, he "made the run" to secure a claim when the Cherokee Strip was opened. His claim was located in what later became Woodward County.

His last years were spent living with the children in Ashland and Oklahoma. He was a member of the Major Elliot Post of the G.A.R. and enjoyed visiting with Mr. I.N. Cassity and other members as they re-lived their experiences in the Union Army in the Civil War. None of the family is now living.

I.N. CASSITY FAMILY

Among the early pioneers of the Ashland community were Mr. and Mrs. Isaac Newton Cassity and family. Mr. Cassity was born in Boone County, Indiana, March 11, 1842. He enlisted in the Union Army in Company F, 11th Regiment, Indiana Infantry, in the Civil War. After his discharge in 1866, he married Eliza Maria Casteel, whose birth date was June 30, 1848. To this union nine children were born: Nora Ann, Arthur, Ora, Lucretia, Olive, Harriet, George, May and Roy. All were born in Indiana except May and Roy who were born in Kansas.

The family moved from Indiana in 1883 to Sedgwick County, Kansas, where they lived on a farm until moving to Wichita. Mr. Cassity learned that government land was available for pre-empting in Clark County. He made the trip to stake his claim and build a sod house about 12 miles west of Ashland in the Vesta area. On December 3, 1885, the family started to western Kansas in a covered wagon filled with children, a stove, some furniture, bedding, and food supplies, and a cow and calf trailing behind. The first week the family camped by the trail and slept in a tent. When the blizzards came, they had to stop at farm houses where they were always welcomed to stay overnight or until the storm subsided. It took two weeks to make the trip. The children walked three miles to the Vesta school.

A severe drought, crop failures, and the loss of the first sod house by fire discouraged the family, and they moved to Ashland in 1888 where Mr. Cassity obtained work as a section hand for the Santa Fe Railroad. Here they became a part of the Ashland community and were charter members of the Christian Church. Mrs. Cassity died May 15, 1922 and Mr. Cassity died July 7, 1927. Only two grandchildren are now living.

In April, 1919, the family returned to Ashland. Mr. Curtis was employed as mail carrier on the Lexington Star Route for nearly twenty years. They celebrated their 50th Wedding Anniversary in 1951. ROY AND CLYDE JOHNSTON DUVALL

Roy Duvall, son of George Alonzo (1868-1951) and Isadora Arvilla Baker Duvall (1869-1939), was born at Shelbyville, Illinois, August 8, 1892. The family moved by covered wagon to Wellington, then to Medicine Lodge to a ranch where the Indian Peace Treaty had been signed. He remembers Carry Nation with her hatchet chopping on saloons.

In 1897, the family moved to their ranch 12 miles west of Ashland, with 7-year-old Roy driving 500 head of sheep, five cows and extra horses. Fred Hinkle, a boy of 7, joined the cattle move before they lost one-third of their sheep crossing Kiger Creek.

Roy was considered the fastest sheep shearer in this area. Around St. Jacobs Well, the pasture was good. He lived in a dugout until 1915, when a two-room house was added. Washing was done on a board, kerosene lamps were used, 12-14 hogs were butchered yearly, and food was mutton, beef, milk and churned butter. Wood, cowchips and coal provided heat and cooking fuel.

Roy and his brothers made it safely home from a country school during a blizzard but Mrs. Nola Aniston, the teacher, was found frozen to death. It was free-range country and the boys were sent horseback to reclaim lost animals. Roy worked 56 head of mules. A 1-row lister pulled by horse-teams plowed no more than 2 acres/day. Maize was cut by hand and the maize heads thrown into a wagon. Men pitched or forked wheat and hay into stacks for threshing. Roy worked Mexicans as herders and shearers.

Roy was a good mechanic, repairing machinery for many neighbors. He loved horses and often carried the flag in parades. "Goldie Mare," a beautiful Palomino, was brought to town for children to ride (with eight riding at the same time!). Farming and ranching were his jobs. He never fussed with neighbors,

drank nor smoked. He was partially deaf.

Roy and Clyde Opal Johnston were married at Lipscomb, Texas, May 16, 1925. They have two sons: George Roy and Harold Ray. Roy has lived 87 years in Clark County. He retired in 1967 and built a house at Eighth and Walnut. Clyde loved working inside and out. She painted, made fair floats and won many blue ribbons, and was an active member of the Ashland community and of their Methodist Church.

FRED EDWARDS

Fred Edwards, who came up the trail from Texas, had worked on the Taintor Ranch, belonging to Chalk Beeson, at which place he worked a year or two. He came to town the winter of 1885-86. Fred was a Mexican and was raised a Catholic until he was four years old when he was kidnapped.

After that he was thrown with the roughest, toughest of people. He could change from the kindest man to a real fighter at a moment's notice.

Willis Long, City Marshall of Englewood at this time, asked Fred to be the City Marshall. The next morning after he was put in office, he went out on the street--as he told it. "I was surprised. There were sixteen out-houses along the street. It sure made me feel bad. Well, I waited till two o'clock. The gang, eleven in all, were standing in front of the post office. John Folley looked awfully big. They all laughed at me. I told them to move the houses back to where they got them. I gave them one hour to move them back. If they did not, I would have the Governor send me one hundred state soldiers. A lawyer told them it would go hard with them if the state took a hand. Every house was moved back in its proper place."

Ifie grew to adulthood under the care of her mother's people. "Geo. W. Espey's daughter, Miss Ifie, arrived Monday from Hull, Iowa, where she has been in school. She is a handsome and accomplished young lady and will be a valuable addition to our society. Still there is plenty of room and a hearty welcome for more of the same kind." Clark County Clipper July 22, 1886.

"Miss Ifie Espey returned to school at Pattersonville, Iowa, the first of the week. Frank Arnold accompanied her as far as Wichita and then ran down to Anthony. (His parents resided there.) The fact cannot be disputed that Ashland has more gallant young men and ladies than any town of its size in the state. As proof of this, we need but mention the little party given in the parlors of the State Bank last Friday night by Frank Arnold, in honor or Miss Ifie Espey, who left the Sunday morning following for school in Iowa. Only a select few were invited, consisting of six or seven couples and a most elegant time was had. Such acts of sociability are a credit to any town, especially when performed by one of our young men." Clark County Clipper September 9, 1886.
